

CHANGE NOTICE FOR MANUAL NO. 11-13, CHANGES RELATED TO 2014 COST-OF-LIVING ADJUSTMENT (COLA)

DATE: JANUARY 16, 2014

Manual: Aged, Blind, and Disabled Medicaid

To: County Directors of Social Services

Effective: January 1, 2014

I. BACKGROUND

- A. The 2014 Cost of Living Adjustment (COLA) is 1.5 percent for Social Security benefits and Supplemental Security Income (SSI) payments. Social Security benefits increased by 1.5 percent effective December 2013. These benefits are payable in January 2014. Federal SSI payment levels also increased by 1.5 percent beginning with the January 2014 payment.
- B. The Veteran Affairs (VA) cost-of-living adjustment is the same percentage as the Social Security benefits. Veterans will receive their increase in the January 2014 payment.
- C. The Social Security Act contains provisions for the protection of income and resources when an institutionalized spouse has a community spouse. 2014 SSI and spousal impoverishment standards are updated throughout the ABD manual as applicable.

- K. MA-2360, Medicaid Deductible, Medicare Part A and Part B premium, deductible and co-insurance amounts are updated, including all related examples.

- M. DMA-5179, MAABD Eligibility Overview Chart, is updated.
