RE: Revision to Chapter XIII: Child Welfare Funding Manual, Section 1700 – Guardianship Assistance Program.

EFFECTIVE: Immediately

I. BACKGROUND | CHANGE INTENT

The Child Welfare Funding Manual has been updated to incorporate the changes needed for the approval and implementation of the State's IV-E Plan, to clarify certain areas of policy; including circumstances under which Guardianship Assistance benefits are terminated, and other language and formatting updates. Revisions made to the policy are in red underlined font.

II. SPECIFIC CHANGES

The changes include:

- I. Purpose and Legal Basis Addition of language related to Fostering Connections to Success and Increasing Adoptions Act of 2008 as follows:
 - This Act also requires states who have implemented a guardianship assistance program to exercise due diligence in identifying and providing notice to adult relatives and all parents having custody of siblings of their options for participating in the care and placement of the child, and the process and requirements for subsequently entering into a guardianship assistance agreement.
- II. Definitions Clarification of Guardianship Assistance definition.
- III. Eligibility Addition of the following:
 - Eligibility criteria a. The child has been removed from his or her home pursuant to a voluntary placement agreement or as a result of a judicial determination to the effect that continuation in the home would be contrary to the welfare of the child.
 - Revision of eligibility criteria, formerly letter b., now letter c. to clarify that a child is eligible for guardianship assistance benefits if the child is <u>eligible for foster care maintenance</u> <u>payments</u> and has been placed in a licensed home of the prospective legal guardian for a minimum of 6 <u>consecutive</u> months.
 - Revision of eligibility criteria, formerly letter d., now letter e. to include criteria for sibling eligibility that the prospective legal guardian and the county child welfare agency agree on the appropriateness of the arrangement for the sibling.
 - The addition of an option for continuation of benefits to age 21 if warranted due to some physical or mental disability with the state's approval. Additional guidance on this new

approval process will be issued with later correspondence.

- IV. Guardianship Assistance Program Requirements Addition of the following:
 - o Letter A. Permanent Plan of Legal Guardianship Case Plan Requirements
 - Letter B. Guardianship Assistance Checklist Addition of language regarding determination of the extension of guardianship assistance benefits to age 21 for a child who has a mental or physical disability.
 - Revision of language under Reimbursement Process to clarify that Guardianship Assistance payments are provided on behalf of children to individuals who assume legal guardianship of children and youth for whom they have cared for as foster parents and for whom they have committed to care for on a permanent basis.
 - Addition of letter G. Medicaid and Social Services.
- V. Documentation and Periodic Reviews Addition of more specific language regarding the
 responsibility of the legal guardian(s) to notify the county child welfare agency of changes
 related to their legal responsibility or financial support for the child. Addition of language
 regarding the requirement that counties must ensure that children who receive guardianship
 assistance benefits and are compulsory school age are enrolled full-time in elementary or
 secondary school or have completed secondary school. If the child is not enrolled as a fulltime student, documentation must support that the child is unable to attend on a full-time
 basis due to a medical, physical, or therapeutic condition.
- Addition of X. Termination of Guardianship Assistance Benefits/Payments This section describes the specific circumstances under which guardianship assistance benefits will be terminated.
