I. BACKGROUND

Effective August 30, 2002, the FRD505 Quarterly Status of Claims Report is revised. These changes are outlined below. Use these pages to replace pages 20-22 in the EPICS User Guide, Appendix F: Reports Section, revised July 15, 2002.

II. UPDATES

The FRD505, Quarterly Status of Claims Report, shows the status of food stamp claims for a quarter and is used for review and balancing purposes. The FRD505 runs on a quarterly basis, is viewable at the owner county level, and is available in XPTR. The retention period for this report is for administrative value only.

| Line 20 – Closed Claims | This line is used to show all claims closed during the given quarter for each heading IPV Fraud, IHE Non-Fraud, AE/SIE Non-Fraud). Closed is defined as receiving payment in full or |
