CHANGE NOTICE FOR MANUAL NO. 03-25, 2025 FEDERAL POVERTY LEVEL CHANGES (FPL) INCOME CHANGES

I. BACKGROUND AND CONTENT OF CHANGE

Federal law requires poverty levels to be adjusted annually on the basis of the Consumer Price Index (CPI). This letter issues the 2025 Federal Poverty Level (FPL) income limits effective April 1, 2025.

In addition to FPL annual adjustments, The Division of Health Benefits (DHB) has updated Medicaid policy sections MA-2180, Health Coverage for Worker with Disabilities (HCWD), MA-2230, Financial Resources, and MA-2311, LIS Processing and Case Maintenance in order to provide clarity and/or corrections to previously published guidance for the Aged, Blind, and Disabled (ABD).

- C. MA-2311 LIS Processing and Case Maintenance

- 4. **Section VII. Determining Eligibility For The LIS**: This section has been updated to include; B. Determine the countable resources and use the LIS Countable Resources Table 2 below.
- 5. MA-2311- LIS Processing and Case Maintenance resource limit have been updated.

- 6. MA-2311 LIS Processing and Case Maintenance Table 1, 2 and 3 have been updated.
- 7. Reference to the DMA-1054, Report of Approval/Denial of LIS Application has been removed.

The 2025 FPL income limit increase is effective April 1, 2025.

Medicare Help Extra resource limits are effective January 1, 2025.
